Our UMW Purpose, says, "The organized unit of United Methodist Women shall be a community of women whose purpose is to know God and to experience freedom as whole persons through Jesus Christ; to develop a creative and supportive fellowship; and to expand concepts of mission through participation in the global ministries of the church."

In order to be whole persons through Jesus Christ, we must draw near to God and listen to that gentle whisper (1 Kings 19:12; NIV) and also get to know ourselves. Women's Division Proposes Becoming "Structurally Separate, Missionally Connected" to Global Ministries. Harriett Olson of the Women's Division, stated in a recent article concerning the proposal to restructure the UMW, "This plan 'will strengthen United Methodist Women's identification with our work in the world and will enhance our strong witness in the church and the world.'"

Our United Methodist Women are accomplishing a lot in our local and global ministries. We are making a difference in the world! It is my understanding that this proposal to restructure will give us more voices at the table and more flexibility in our organizational structure. We will be able to continue as we are doing things now at the Conference, District, and Local Levels, but we will be permitted to function with less officers if we desire, as long as we have at least a President, Secretary, and Treasurer.

Often we are first responders in times of crises. I attended training in Nashville, Tennessee this year, where Harriett Olson told how they had already sent representatives from the UMW to Japan to give aide. Also, at this meeting, a missionary from Japan spoke on her experience as the earthquake hit. With a membership of over 800,000 women, united as one, our continued efforts to come along side of and feed, clothe, educate, and show God's unconditional love to the needy, especially the women, children, and youth, is paramount. And I believe equally as important is our legislative advocacy, to try to stop the abuses at their source. As you may know, this year we are focusing especially in the area of Human Trafficking, Immigration, and Domestic Violence. Vice Presidents

Ladies, you have survived the first half of the year. Your plans for events (Prayer Breakfast, Leadership Training, Spring Meeting, etc) went better than you thought it would. Why? Good planning and organization! You used the Handbook 2009-2012 (section heading: Program Planning pages 117-134) that outlines what is needed for any type of program. United Methodist Women engages in a process of Study, Action and Reflection that is centered on the PUR-POSE and surrounded by worship (page 117).

Before the program takes place, gather the Program Committee (you are the chairperson) and discuss the goals of each program. As discussions are taking place use the Action Plan Form (p.119) to outline the entire event. Include everything needed for the event (place, speaker, worship, publicity, music, rooms, microphone, audio-visuals, materials, tables, food, etc). Be sure to plan for each event at least 6-12 months in advance to cut down on rushing at the last minute. You need time to line up popular speakers (their calendars fill up sometimes a year in advance). Use beginning and end dates for each line item. Be sure to give enough time to complete all the details before the program or event. Remember to review evaluations from past programs to improve on future programs.

TIPS FOR HANDLING CONSIGNMENT ORDERS – DISTRICT PROGRAM RESOURCE SECRETARIES

Greetings to all my sister Program Resource Secretaries! Now after experiencing the **Consignment** process for ordering books and materials from the Mission Resource Center, I have come up with some tips that should be helpful in streamlining this whole process and eliminating any headaches (hopefully!)

- 1. Order all books and materials around SIX WEEKS before your event. Then if you don't receive everything you order, you have time to call the Resource Center to let them know and they will usually send what you need on time.
- 2. ALWAYS check your order when you receive it.
- 3. If you don't have one, purchase a small hand cart/luggage carrier to transport the boxes of books. Lots of times it can be quite a distance from your car to the set-up area. (You can ask for reimbursement, provided you plan to pass the cart along to your successor.)
- 4, ARRIVE EARLY ENOUGH AT YOUR EVENT TO HAVE EVERYTHING SET UP AND READY WHEN THE FIRST PARTICIPANTS ARRIVE. YOU WILL INCREASE YOUR SALES AND HAVE A CHANCE TO ANSWER QUESTIONS.
- 5. Decorate your table with colorful and attractive tablecloths or fabric.
- 6. Create eye-catching signs for the different Reading categories, School of Christian Mission study books, and Officer supplies.
- 7. Have prices visible on all items. Post-it notes are OK. If you buy labels, use only the REMOVABLE ones, as the permanent ones can cause damage when you have to take them off to send materials back to the Center. You will be charged for any damaged materials.
- 8. Physically separate and label all the free materials from those you are selling.
- Make sure you have asked your District Treasurer ahead of time for start-up cash. Folks tend to
 have a lot of twenty dollar bills with them! You will also need some quarters, dimes and nickels.
- 10. Remember to have a calculator and cash box with you.
- 11. All checks are to be made out to "Mission Resource Center".
- 12. If someone says, "I'll be right back with the money," keep the books with you until the cash or check is in your hands.
- 13. Folks often ask for bags for their purchases. If you're like me, you have a surplus of plastic grocery bags. These do just fine, especially if it is raining.
- 14. Make sure you have your two copies of the Daily Accounting Form with you so that you and your Treasurer can complete them at the end of your event. This form is fairly straightforward but requires a **very detailed** listing of all currency, coin and checks. The Treasurer has only **ONE** week after the date of your event to send sales remittance and the Accounting Form back to the Center
- 15. Even though the Center allows you **30 days** to return the unsold materials, my advice is to send them back within the first week after your event. Keep those headaches at a minimum!
- 16. The Mission Resource Center sends UPS return labels. Find your most convenient UPS location and drop off those boxes. Check out Staples. My local Staples has UPS shipment available.

Social Action Update

Ecumenical Advocacy Days (EAD) 2011, Washington, DC

I was one of over 700 persons from the national faith community who gathered at the Double Tree Hotel, Crystal City, VA, March 25-28, 2011, to discuss and share experiences on domestic and international security, development, and economic justice, with a focus on impacts on women. EAD is sponsored by many national faith-based organizations, including the United Methodist Church, and the Women's Division of the General Board of Global Ministries.

EAD 2011 included many provocative discussions and presentations. Spirit-filled worship services and plenary sessions helped to unify our thoughts on justice-related responsibilities within the world community. Advocacy was a recurring theme in workshop sessions and in jurisdiction and state workgroup breakouts. The eight workshop areas included Africa, Asia-Pacific, Domestic United States, Global Economic Justice, Latin America, Eco-Justice, Middle East, and Peace and Global Security. We spent the final day on Capitol Hill visiting legislators to gain support for several legislative initiatives. And, we ended EAD 2011 on Capitol Hill in a prayer vigil to bring attention to issues with the proposed federal budget cuts.

It is well-known that women are often exposed to some of society's worse ills. They suffer impacts of various global challenges resulting from climate change, food insecurity, natural disasters, and the like. In some settings, they endure genital mutilation and child marriages. The world's billion hungry people are mainly women and children. Women experience inordinate amounts of sexual and physical abuse, not to mention the huge impacts of human and sex trafficking, and undocumented immigration. We note that the role of women has begun to change internationally as they use communications technology to connect with others globally, and begin to move into development areas within their countries. Even so, much remains to be done around the world to improve the status of women.

As members of the faith community, we must work to help resolve social justice issues everywhere. Our charge is to be the justice-centered focus for the poorest, most uneducated, unloved, and otherwise disadvantaged persons among us, who are too often women and children. We know that when women suffer, the entire community suffers!

Storytelling and relationship-building are critical to social justice advocacy activities. Successful advocates build coalitions and relationships with members of other advocacy organizations and interest groups; local, state, and national legislators; and community, national, and world leaders. Successful advocates also participate in public witness activities, e.g., rallies, prayer vigils, testimonials, and e-mail, letter writing, and other such campaigns to help influence the thoughts and actions of others.

Legislative advocacy for EAD 2011 focused on several initiatives and resources that serve poor and vulnerable persons among us. Specific legislative requests addressed in our visits with national legislators included:

(Social Action Update, cont.)

Re-authorize / fully-fund the Violence Against Women Act, and enact the International Violence Against Women Act

Fully fund, in the 2011 / 2012 national budgets, programs that serve women and families at or above FY 2010 levels

Support forgiveness of debt to the US of underdeveloped nations to enable them to improve services / communities for their own citizens and residents.

Women are the glue that holds families and communities together. Secretary Clinton has said, when women receive needed help and support, "they flourish, their children flourish, and so does the greater community." EAD 2011 was a dynamic and information filled annual event. Perhaps you will consider attending in 2012! REPORT—WORLD FEDERATION OF METHODIST AND UNITING CHURCH WOMEN

Combined States Meeting

March 12, 2011—Union Wesley AMEZ Church

I was honored to represent the Greater Washington District and our President, Mrs. Gertrude White, at the Annual Meeting of the World Federation of Methodist and Uniting Church Women's Annual Combined States (DC, Maryland and Virginia) meeting, which was held at Union Wesley African Methodist Episcopal Zion Church in Washington, DC. There were approximately 60 -70 women present (and one man that I saw) from African Methodist Episcopal (AME), African Methodist Episcopal Zion (AMEZ), Christian Methodist Episcopal (CME) and United Methodist Churches (UMC) throughout the Washington Area, although the majority of congregations represented are located in DC. As far as I know, I was the only UMW member at the meeting.

The meeting consisted of continental breakfast, singing, a Bible Study, presentations on two of the social justice issues that the Federation has adopted—World Hunger and Universal Education, and prayers from each of the faith groups represented. I was asked to give the opening prayer and one of the closing prayers. The Bible study was presented by a CME pastor, who is on staff at a local church and at Providence Hospital. The presentation on world hunger was given by Marco Grimaldo, a staff member of Bread for the World, and included a powerful video about this year's Offering of Letters. The education presentation was given by an officer of the Federation who was filling in for a representative from UNICEF, who was unable to attend.

Because the meeting took place on the morning after the devastating earthquake and Tsunami in Japan, the victims and survivors and the communities affected were prominent in our prayers, as well as the social justice issues that were being highlighted at the meeting.

The information presented was solid and educational, the Christian Sisterhood shared was energizing and the power of women uniting in prayer was palpable. I would encourage our district to send a larger contingent to the next meeting.

Proposed Changes, What's Staying the Same, & The Proposed Advantages

Proposed changes:

The Women's Division will structurally separate from General Board of Global Ministries.

The title of "Women's Division" will become "United Methodist Women."

The board of directors will reduce its size from 50 to 25 members, with the task of fiduciary management.

A Program Advisory Group, composed of 70-80 members, will recommend programmatic policies to the Board of Directors.

The term "unit" will be replaced with "local organization of United Methodist Women."

Fewer officers will be required.

What's staying the same:

The PURPOSE.

The focus of United Methodist Women for women, children & youth.

The priority of social justice and advocacy work.

The streams and processes of funding United Methodist Women mission.

The main advantage: More flexibility.

The proposed reorganizing of the Women's Division Board of Directors and United Methodist Women leadership teams independently from GBGM means more flexibility to **grow in mission** with women, children and youth around the world.

More flexibility...

Enables mission teams at all levels to **organize how they best see fit** to fulfill the Purpose and do the work according to their community's, church's, and members' needs.

Enables your mission team to **remain the same** if your organizational structure is working for you.

Enables the Women's Division to **advocate more strategically** on behalf of women, children and youth within The United Methodist Church by moving from a division to an agency.

Enables the Women's Division to **broaden its priorities across the church** by working directly with other agencies through the General Secretaries' Table.

Enables United Methodist Women members from every Annual Conference **representation** on the Board of Directors and Program Advisory Group and thus **fuller participation** in the organization.

Keep in mind, these are proposals to be brought to General Conference in 2012, and we do not know what will result from the voting. Any changes will not be implemented officially until January 2013; however, the Women's Division will prepare for implementation following General Conference.
